The Promise:

DUP SPIN:

"A DUP veto on North/South Decisions"

Unionists already had a veto on North/ South decisions. In fact, the DUP have now agreed to establish an additional All Ireland Parliamentary Forum and an All Ireland Civic Forum.

THE FACTS:

"Implementation of measures to ensure fairness and equality for Unionists"

Where? Do they mean the Irish Language Act that puts the Irish language on an equal footing with English? Or access to Republic of Ireland nationals to all Civil Service posts in Northern Ireland?

"A testing period to ensure Republicans have delivered"

Only until next March - after which the DUP has thrown away the existing exclusion mechanism to put Sinn Fein out of government should they default.

"An automatic end to 50/50 recruitment as soon as composition of the PSNI reaches 30% Roman Catholics"

50/50 Police Recruitment will be scrapped when the Patten target is met anyway. This is nothing new. For the first time, a unionist party - the DUP - has endorsed the institutionalised discrimination in Patten.

"Commitment to increased funding for Victims"

Where in the St Andrews Agreement does it promise Victims Funding?

The DUP claims to have saved Academic Selection, and secured a cap on rates, control over water rates and a block on the new Super Councils.

Every single one of these issues is actually dependent upon a cross-community vote in a restored Assembly. The DUP can do none of this by itself.
